

## GAMBLING AND MATCH-FIXING POLICY - QUICK FACTS

The manipulation of sporting competitions and related activities undermines the integrity of sport and all its participants and stakeholders. Basketball Australia is committed to taking every step in its power to prevent corrupt betting practices within the sport of basketball.

### Who is bound by the policy?

Any participant or club involved in any match, event, competition or Basketball Activity that attracts a betting market including;

- Participants in any national basketball team or squad associated with Australian national basketball team, wheelchair, 3x3 and junior nationals
- Participants in the National Basketball League (NBL)
- Participants in the Women's National Basketball League (WNBL)
- Participants in NBL1
- Participants in the BigV League or equivalent leagues
- Participants in Australia Junior Championships
- Any person holding media accreditations

The definition of Participant for this Policy includes; Athletes, Coaches, Administrators, Officials, Athlete and Team Support Personnel, as well as Directors, Employees, Volunteers and members of governance and management committees involved in the above competitions.

#### What is prohibited conduct?

- Betting including;
  - Placing, accepting, offering, laying or otherwise entering into ANY bet on basketball, including the NBA
  - Bets on any basketball which includes competitions you are not involved in
  - Soliciting, including or instructing another person to bet
- Misuse of Inside Information including;
  - Disclosing inside information to any person to give them an advantage on betting
- Corruption including;
  - Participating in fixing or improperly influencing or altering a result which may include;
    - Deliberately underperforming
    - Providing false information
    - Intentionally modifying playing surfaces or equipment
    - Providing or receiving any benefit that may bring the game into disrepute
- Failing to report;
  - o Persons must report any prohibited conduct to Basketball Australia's Integrity Unit
