## **Key Responsibilities**

- Support the Head Coach in technical preparation, planning, and delivery of the program
  - Assist with talent identification and selection of athletes for squads and teams throughout the campaign
  - Liaise with Head Coach and Basketball Australia Centre of Excellence coaches to align style of play and respond to international trends
  - Conduct high-level scouting and analysis of international opponents and competitions

## **Desired Experience and Skills**

- Demonstrated experience coaching elite youth men's basketball
  - Coaching experience at WNBL, NBL or NBL1 level
  - Head coaching experience at Australian Junior Championships
  - Active involvement in the Basketball Australia National Performance Program (NPP) or State Performance Programs
  - High-level video scouting and analysis capability
  - Strong demonstrated player development experience
  - Understanding of Basketball Australia's style of play philosophy
